4. Electronic medical records improve patient care and the public health benefits by the use of electronic medical records. Dear Mr. Miller.

As Chief Information Officer for the Western Hemisphere regional office of the International Planned Parenthood Federation (IPPF/WHR), I am writing to commend the OpenEMR Project on the usefulness and affordability of its software for health care in low resource, community clinics.

The member organizations of IPPF provide sexual and reproductive health care to women, men, and adolescents. It is IPPF's mission to meet the needs of those who are poor and underserved. In 2015 OpenEMR was utilized in 30 clinics and served over 310,400 clients in 13 developing countries of the Caribbean and Latin America. In 2016 OpenEMR will be implemented in two additional Latin American affiliates of IPPF, and serve an additional 88,000 clients. Approximately 86% of all clients served by the clinics using OpenEMR, are poor marginalized or socially excluded and underserved populations within the country.

All of the IPPF/WHR member affiliates using OpenEMR in the Caribbean and Latin America are small, non-profit organizations with limited financial resources. They cannot afford commercial health system software. OpenEMR has enabled them to replace manual, paper based logs with an efficient electronic system. It's been an extremely useful tool for clinic administration, providing clinic performance and client care follow-up.

OpenEMR provides Member Associations with a point of sale system to collect payment for services and products provided in their clinics. It supports inventory management of high value pharmaceutical products. In addition to facilitating clinic practice management, its electronic health record features support our delivery of major reproductive health services, include gynecology care, cervical cancer screening and treatment, as well as STI/HIV testing and counseling. As you can imagine, each country has its own requirements and OpenEMR has been easily customized to fit the needs of each country.

We look forward to future collaboration with the open source OpenEMR community, as well as expanding use of this affordable, multi-lingual system in clinics of additional developing countries.
